Peace and Greetings to the transsexual lesbians!
This is Amazon putting out this zeen about
things tranzlezbian.

First of all, this zeen is being kicked out from
Corcoran Prison, California. I am Amazon, also
known by other names, but this one stands out
most and best as my lesbian name. It speaks to
my physical features: I am 6'1" and weigh about
200 lbs right now. I have put on some weight
since starting hormones some months ago, but
this is no excuse or attempt to "explain" being
that weight. Skip the guilt complex and just
live, ha! I exercise often, daily when I can.
I am a Kupa Native, called an "Indian" by
the government and most others. I don't use
that term for my own reasons, but it is being
used. I get dark in the sun (real dark!) and
have kinda a "big bone" structure or frame,
and have Native facial features. I am doing a
life term and have been in prison 28 yrs to
date, no telling when they will let me out but
I am doing what I can to put some space
between me and this place. I do expect to get
out some day though.

My love life is Belladonna, another tranz-
lezbian in prison for life. She is a white
girl, very milk white, 6'4" and about 185.
She is also on hormones and developing body now
whereas she used to be very thin. Still is,
kinda, but getting curves too in all the right
places, ha. She has long brown hair, which I
wear a lock of at all times, tied to a lock of
my own hair. That way she is always with me or
we are always together in a symbolic way in
addition to our emotional way, since we can't
be together physically for the time being

because she is in the hole (long story that I
will come back to later). She might have been
transferred to another prison by now, I don't
know yet. Our communication is not great right
now but will kick up again soon as she is
settled at her new place.

Me and Belladonna go back almost 20 yrs, when
we first met in a lockdown prison, Pelican Bay
SHU. She eventually went home back then, got
picked up again on a 3-Strikes case doing stuff
on the computer. She got here late last year
and we hooked up again, this time in the more
romantic sense, true love. We were both on
single-cell status due to not getting along
with the men they were celling us up with, who
did not know how to relate to queens other
than to consider sex toys to be used and
abused. I have been on single-cell for the
last ten years or so. We tried to get off so we
can cell up and were working on it when girl
got slammed. She can't kick it with men all
that great. Anyway, long of it short we got
separated again and right now there is no
telling when we will meet again except to say
that we will, for sure, if not on this good
Earth then at Thug's Mansion of a certain.
Our destinies are inseparable. We know this
from our belief in certain spiritual/occult/
psychic perceptions we have. We are strong on
Goddess. It is the Goddess Who has given us
the blessings of Womanhood and favored us as
Her divine children on Earth, and has bestowed
on us Her sacred medicine in the form of female
hormones that we may be women in Her holy
image. We ritually say when we take our
hormones, in Her words: This is my body. Take
of it and you shall be woman forever. Glory!!!

Getting our hormones in prison was a very, very
trying experienced, but in the end we were
blessed. We are so grateful for it!

NOW I JUST WANTED TO NOTE SOME POETRY FOR THE DAY. A FEW LINES WILL DO IT FOR THIS, AND WE WILL HAVE MORE IN THE FUTURE WHEN WE HAVE GONE OUT TO OTHER PLACES, MET OTHER TRANZLEZBOZ AS OURSELVES, AND IMPROVED OUR PUBLICATION CAPABILITIES. WE SEE THIS ZEEN EXPANDING IN FORMAT IN DUE TIME, AS MORE PARTICIPATION IS ACCOMPLISHED. SOME OF THESE POEMS ARE MY OWN THAT I DID THROUGH THE YEARS IN PRISON. I ONCE HAD A COLLECTION, CALLED 'ICE COLLECTIONS: THE POETRY OF AMAZON ICE QUEEN.' BUT IT GOT TRASHED BY THE PIGS IN A TRANSFER TO SHU. BUT ALL IS NOT LOST BECAUSE I MEMORIZE ALL OF IT. SO HERE IS SOME OF IT FOR YOUR READ:

PEEKED TITS ON A GIRL,

THAT IS PRETTY DIRECT STUFF, WHICH IS HOW MOST OF MY STUFF COMES OUT. THIS ISSUE IS ONLY GOING TO BE FOUR PAGES, SO ONLY THESE TWO WILL APPEAR THIS TIME. WHEN WE HAVE MORE PAGES THERE WILL BE MORE, AND WE DO WANT TO HEAR FROM YOU TO PUT IN YOUR OWN HEARTFELT SPIRIT-TALK (WHICH IS WHAT POETRY IS) IN THESE PAGES. THIS IS YOUR ZEEN, NOT "OUR" ZEEN OVER HERE, OKAY BABY? BUT OF COURSE! I WROTE ONE ABOUT ME AND BELLADONNA FIRST MEETING IN SHU. I WILL PUT IT IN THE NEXT ISSUE AND HOPE IT GETS TO HER. THE WORD IS SHE HAS BEEN TRANSFERRED, BUT NOT SURE YET. THAT HURT, IF TRUE. ALSO, MY DAUGHTER BLONDIE WENT TO THE HOLE SHORTLY AFTER BELLADONNA DID, AND I HAVE NOT HEARD OF HER FATE. SHE SHOULD HAVE BEEN BACK BY NOW.

BELLADONNA IS IN THE HOLE, "AGAIN" I SHOULD ADD. THE GIRL IS MY LOVER. SHE HAS BEEN HAVING RECURRENT PROBLEMS WITH CELLMATES WHO ARE MEN. WHEN SHE GOT HERE LAST YEAR WE WERE BOTH ON SINGL-CELL STATUS. WE HOOKED UP, TRIED TO GET OFF SO WE COULD CELL UP WITH EACH OTHER "ONLY." THE ADMINISTRATION TOOK US THRU SOME TRIPS, GOING BACK ON THEIR WORD AS THEY DO BEST, AND IN THE END LEFT US HANGING WITH GIRL OFF AND ME ON. WE WAITED FOR THEM TO GET THEIR GAME IN ORDER, BUT SHE GOT INTO SITUATIONS AND WE REALLY WANTED TO PUT SOME PRESSURE ON THE STAFF TO GET THE KICK- STAND UP ON IT. NOTHING WORKED. FINALLY GIRL DID WHAT SHE HAD TO DO AND WAS BACK IN AD-SEG. WE WROTE TO EACH OTHER THE OTHER TIMES SHE WENT TO THE HOLE FOR SHIT WITH CELLIES (WHO TRIED TO CONTROL HER - BIG MISTAKE!!!!), BUT THIS TIME AROUND OUR CORRESPONDENCE WAS CUT. I HAVE NOT HEARD FROM HER IN ABOUT TWO OR THREE MONTHS. BUT I THINK SHE IS STILL OVER IN AD-SEG. I WILL LEARN SOMETHING SOON.

MEANWHILE, I HAVE AN APPEAL OUT FOR A CHRONO TO HAVE A TRANSSEXUAL CELLMATE ONLY DUE TO BEING GIRL AND ALSO DUE TO BEING ON HORMONES. THIS IS A FACTOR FOR ALL GIRLS ON MONES WHO ARE HAVING TROUBLE GETTING A COMPATIBLE CELLIE. WE NEED SOMEONE LIKE US WHO CAN UNDERSTAND THE KINDS OF EMOTIONAL CHANGES THAT TAKE PLACE WITHIN US WHEN WE ARE ON MONES, AND BE THERE WITH EMOTIONAL SUPPORT IN THOSE CRITICAL TIMES OF OUR TRANSITION. SOME GIRLS CAN GET WITH A MAN AND THAT WORKS FOR THEM. SOME REALLY CAN'T WORK IT WITH A MAN. WE ARE DIFFERENT. I MYSELF AM JUST LESBIAN AND ONLY GO WITH OTHER GIRLS. I AM ON SINGL-CELL DUE TO MEN ASSAULTING ME, DEFENDING MYSELF, GOING TO THE HOLE, SHU, ETC. GAME OVER. OF COURSE IT IS NOT JUST THAT FACTOR. MOSTLY IT IS JUST MY NATURAL BENT TO GO WITH ANOTHER GIRL. NOTHING NEW AGAIN, RIGHT?


LET'S SEE. I HAD ALSO FILED A PETITION IN COURT WHEN I WAS IN THE MIDDLE OF MY EFFORTS TO GET MONES HERE, AND IT IS STILL ON. I AM USING IT TO KEEP THE PRISON IN CHECK ON GETTING WHAT THE DOCTOR PRESCRIBED. ALSO, THE PRISON'S LAWYER HAS TRIED TO GET THE CASE DISMISSED NOW THAT I AM

GETTING MY HORMONES. HOWEVER, MY PETITION ALSO ASKS FOR SURGERY, NOT JUST HORMONES. THIS IS WHERE IT IS AT AT THIS TIME. THE COURT WILL RULE IN JANUARY ON THIS REMAINING ISSUE, AS WELL AS KEEPING MY APPOINTMENTS ON SCHEDULE IN GETTING WITH THE THERAPIST. I WILL REPORT ON ALL THIS IN JANUARY (THIS IS DECEMBER 2008, BY THE WAY).

ANOTHER THING IS GETTING BRAS. BELLADONNA HAS A CHRONO FOR A BRA DUE TO BEING ON MONES, DEVELOPING BREASTS. I HAVE ASKED TO SEE THE DOCTOR HERE FOR AN EXAM TO VERIFY BREASTS (FROM PRIOR USE OF HORMONES, AND NOW THEY HAVE BEGUN TO GROW), BUT I HAVE NOT HEARD ANYTHING OR BEEN CALLED TO THE CLINIC TO SEE THE DOC. I IMAGINE THEY ARE TRASHING THESE KINDS OF REQUESTS FROM US GIRLS FOR THEIR OWN REASONS. I HAVE MENTIONED IT IN MY MOTIONS TO THE COURT AND HAVE ASKED THE JUDGE FOR AN ORDER FOR A BRA. JAMIE IS ALSO TRYING TO GET A CHRONO. UNIQUE MAKES HER OWN BRAS FOR NOW (AND JAMIE). I DON'T USE ANYTHING BUT AM GOING TO TRY TO MAKE ONE TIL I GET ONE. I EXERCISE A LOT LATELY, INCLUDING A LOT OF JOGGING, WHICH MAKES MY BREAST BOUNCE, NOT GOOD. I NEED A SPORTS BRA. SO I HAVE CUT DOWN ON JOGGING AND AM MOSTLY JUST DOING CALESTHEN-TICS (IF I SPELLED THAT RIGHT; I AM IN THE LAW LIBRARY AND DON'T WANT TO GET UP AND GO GET THE DICTIONARY). I LOVE EXCERCISING TO BE FIT: THE SWEAT, HEAT, CLEARED UP MIND, GOOD HEALTH. THAT IS ONE REASON WHY I AM CALLED "AMAZON." I AM 6'1" AND ABOUT 200 RIGHT NOW. WANNA BE ABOUT 180 OR 190. WHEN I TOLD THE GENDER DOCTOR MY WEIGHT I ADDED, "OVERWEIGHT." SHE ASKED HOW MUCH I WOULD LIKE TO WEIGH. I SAID HOWEVER MUCH I WEIGH WITH BREASTS AND HIPS WILL BE THE IDEAL WEIGHT. SHE LAUGHED.

THIS WRAPS THIS UP FOR NOW. GENDER ANARKY ZEEN IS PUT OUT AT RANDOM, SO NO DATE AS TO WHEN THE NEXT ISH WILL PRINT, BUT JUST IN JANUARY SOMETIME. TO BELLADONNA: I LOVE YOU GREATLY, GIRL, LIKE NO OTHER! I MISS YOU A LOT, NEED YOU CLOSE TO ME, OKAY? I KEEP WRITING TO DNA MOM FOR YOU. HOPE YOU ARE GETTING THEM. BYE FOR NOW BUT NEVER FOREVER!!!!

ALIAS AMAZON ("CHI CHIS" TO BELLADONNA!!!!)

MY NAME IS AMAZON. THIS IS ANOTHER SPIT OF THE ZEEN "GENDER ANARKY" THAT IS PUT OUT BY THE COLLECTIVE KNOWN BY THE SAME NAME. WE ARE FIGHTING IN THE PRISONS FOR HORMONE THERAPY FOR TRANSSEXUAL QUEENS IN THE PRISONS OF CDC, AND FOR SURGERY FOR THOSE WHO WANT THAT TOO. WE MAKE EFFORTS THRU ADMINISTRATIVE APPEALS FOR TREATMENT, AND IF THAT FAILS WE FILE LAWSUITS IN COURT FOR AN ORDER THAT THE PRISON GIVES US THE TREATMENT WE HAVE COMING.

THIS IS BEING SPIT FROM CORCORAN PRISON, MAXIMUM SECURITY. THERE ARE SEVERAL GIRLS ON THIS YARD. SOME OF US ARE ALREADY ON HORMONES (SUCH AS MYSELF) AND SOME ARE TRYING TO GET ON HORMONES BUT ARE HAVING A LOT OF PROBLEMS GETTING THEM, AND ONE GIRL HAS BEEN PRESCRIBED HORMONES BUT HAS BEEN WAITING TWO MONTHS OR MORE TO BE ISSUED THEM BY THE PRISON PHARMACY. I MYSELF HAD TO GO THRU A LONG PROCESS OF APPLYING AT THE CLINIC, NOT GETTING ANY ACTION, FILING AN APPEAL AND THEN A LAWSUIT IN COURT. AFTER HAVING A TELEMED CONSULTATION WITH THE TRANSGENDER SPECIALIST AT THE UNIVERSITY OF CALIFORNIA AT SAN FRANCISCO I WAS PRESCRIBED HORMONES, BUT THEN IT TOOK ONE MONTH TO HAVE THE PRISON ISSUE THEM TO ME, WHEN IT SHOULD HAVE TAKEN JUST A COUPLE OF DAYS OR SO. NOW ~~IT~~ HELPING THE GIRLS GET THEIRS.

I HAVE JUST WROTE A PETITION FOR HABEAS CORPUS FOR ONE OF THE GIRLS HERE, UNIQUE. SHE APPLIED TO SEE THE GENDER DOCTOR, WAS REFERRED TO THE TELEMED CLINIC, BUT THEN THE CMO DENIED IT BEFORE SHE COULD HAVE THE CONSULT. THIS IS NOT THE PROCEDURE. THIS PARTICULAR CMO HAS GONE WILD HERE IN MANY WAYS, A LOT OF HIS ACTIONS DENYING US OUR MEDICAL RIGHTS ARE CONTRARY TO RULES, STATUTES, AND THE LAW GOVERNING MEDICAL TREATMENT FOR US. SO GIRL DID AN APPEAL, WHICH WAS DENIED UP TO SACRAMENTO, AND NOW WE ARE IN COURT. WILL KEEP YOU POSTED.

SHIOH HAD A TELEMED, WAS PRESCRIBED HORMONES, AND HAS BEEN WAITING OVER TWO MONTHS TO GET THEM. SHE HAS FILED

AN APPEAL AND IS WAITING, THO SHE HAS NOT HEARD ANYTHING FROM THE APPEALS UNIT ABOUT HER APPEAL. THIS IS VERY TYPICAL OF HOW IT GOES WITH APPEALS IN THESE PLACES, NOTHING NEW TO YOU. SHE WANTS TO GO TO COURT RIGHT NOW AND WE ARE CONSIDERING IT.

SOME GIRLS WERE ALREADY ON HORMONES WHEN THEY GOT HERE. WE GET TABLETS THAT WE CAN KEEP ON US, AND INJECTIONS EVERY WEEK OR EVERY TWO WEEKS, DEPENDING. THE TABLETS ARE SPIRONOLACTONE (ANTI-ANDROGEN), AND ASPIR-LOW OR LOW ASPIRIN TO PREVENT BLOOD CLOT. THE INJECTION IS ESTRADIOL VALERATE (FOR BREASTS). THE DOSAGE DEPENDS ON THE PHASE OF TREATMENT EACH GIRL IS IN. LIKE I JUST STARTED A FEW MONTHS AGO, SO MY INJECTIONS ARE 20 MGS EVERY TWO WEEKS AT THIS TIME. ANOTHER GIRL, JAMIE, IS GETTING 50 MGS EACH TWO WEEKS, AS SHE HAS BEEN GETTING HER INJECTIONS LONGER. THE GENDER THERAPIST RAISES THE DOSAGE AS SHE SEES FIT.

THE TELEMED CLINICS (OR INTERVIEWS) ARE SCHEDULED HERE THREE MONTHS AFTER HORMONES ARE PRESCRIBED, THEN SIX MONTHS AFTER THAT, THEN A YEAR AFTER THAT AND ANNUALLY THEREAFTER. BUT MY APPOINTMENT FOR LAST MONTH WAS NOT KEPT BY THE PRISON AND I HAVE MADE INQUIRIES WITHOUT ANY RESULTS AND HAVE FILED A (NEW) PINK 602-HC FOR THE APPOINTMENT.

THIS IS AN IDEA OF HOW IT IS GOING FOR SOME OF US HERE. BUT AT LEAST WE ARE ABLE TO GET THEM THRU A PROCESS, AS INEPT AS THAT PROCESS IS BEING WORKED AT THIS PRISON. BACK IN THE DAY WE COULD NOT GET THEM AT ALL UNLESS WE HAD MEDICAL DOCUMENTS OF GETTING THEM ON THE STREET. I TRIED LIKE HELL TO GET THEM BACK THEN: EVERY EFFORT FAILED AND I WENT THRU SOME TRAUMATIC EPISODES THAT YOU DON'T NEED TO HEAR BECAUSE YOU HAVE WENT THRU IT YOURSELF, I AM SURE.
